!!IMPORTANT NOTICES!!

Erin Griffin and his team (For Ringers) built wooden runways at the Vista at the start of the season. They did a significant amount of work and expended their own funds. Their efforts are appreciated; however, there have been some issues expressed by numerous players about safety and fairness. So here is my solution for the balance of this season in order to have some consistency and at least partially address some of the concerns. The 2 wooden runways on one pit will be moved to the other pit so they are equal in design. The placement of the sprinklers will determine which pit the runways are moved to. That means one pit will have wooden runways on both left and right and other will be as it was previously (no runways). Teams scheduled there the last two rounds and during the playoffs can hopefully come to an agreement on which pit to play on. If they cannot come to agreement that is reasonable for both teams, a coin will be tossed. There will be no double-up matches there, so both pits will be available to choose from. Erin has assured me two runways will be moved to the other pit prior to play this coming Tuesday. We thank his team for understanding and being willing to make the changes. We will work with sponsored teams and the owner of the Vista about possibly rebuilding the pits next season to be level with the ground and maybe adding runways. Please give me a call if you need clarification or need to discuss how we are handling the balance of the season. I ask that home teams give consideration about which pits the opposing team prefers to play on if the home team does not have a preference.

Any fees in the arrears must be caught up by (Round 14). A list of all players that are behind in fees after Round 13 has been calculated and captains/players will be notified. Counting round 13 that was played July 14 thru 16, we only have 2 rounds left, so please get your fees up-to-date now. Remember you can use Venmo to pay if that is easier (see QR code in team binder). If you write a check, it needs to be made out to **JADE BACUS**, not BVHL, as my credit union will not accept those written to BVHL.

23 of 26 teams have turned in their team rosters - they were due the first round. I have nicely asked for weeks now - The missing team rosters are: **Whipper Snappers, H & H, and Dead Last**. I realize I can probably determine who the regular players are, but I cannot be sure of the designated subs. Also **Pole Dancers** turned their roster in, but it only listed the team captain information. I need all the requested information. **If Whipper Snappers and Dead Last can text me their official designated subs I can record that information as that info is important for the playoffs.** FYI the rules allow me to charge you \$5 per week until the Rosters are turned in starting with Round 1, but I have never enforced that rule. All 4 bars have paid their sponsor fees. THANKS
